

City of South Sioux City, Nebraska **Sidewalk Permit Requirements** 04/24/18

- 1. In concern for the safety and welfare of it's residents, and to insure that sidewalks are properly installed and located in a consistent manner, a sidewalk permit is required prior to construction. Applications for a sidewalk permit are available at City Hall, 1615 1st Avenue at the cost of \$25.00. It shall be the responsibility of the property owner or contractor to obtain said permit prior to commencing work.
- 2. Sidewalk grades and specifications are as follows:
 - a. Minimum width shall be 4 feet.
 - b. Thickness shall be 4 inches except in those areas where vehicle traffic is likely in which case the thickness shall be 6 inches.
 - c. Slope shall be 1 inch toward the street.
 - d. Locations shall be 2 feet outside the lot line; however, all sidewalks must be installed in line with existing sidewalks.
 - e. Elevation shall be no more than 8 inches above existing curb, nor more than 2 inches above adjacent ground level, but in all cases level with adjoining sidewalks.
 - f. Where sidewalks meet driveways, curbs, or streets a ¾ inch mastic expansion joint must be installed.
 - g. Concrete shall be laid on subsoil firmly compacted and uniform.
 - h. Concrete shall conform with Nebraska State Highway Department specification 47B air-entrained concrete.
 - i. ½" mastic expansion joint shall be placed at intervals not greater than every 60 lineal feet of continuous sidewalk.
- 3. Carriage walks (sidewalks installed next to the curb) are prohibited except where natural barriers, utilities, or other obstacles cause no other alternative placement. If any of these conditions exist, a written request must be made, and permission granted by the governing body.
- 4. All locations where there is an elevation change; such as, a sidewalk meeting a street or driveway; must be handicap accessible. Sidewalk ramps must have a maximum slope of 1:12 and a side slope of 1:10. Acceptable method for curb cuts is by milling or grinding. No saw cuts are permitted.
- 5. Before digging or excavating the owner or contractor shall call the **Nebraska Diggers Hotline at 1-800-331-5666**.
- 6. Any request for variance or modifications to the above regulations shall be submitted in writing and approved by the governing body.

SIDEWALK PLACEMENT


- A. Minimum width shall be 4'.
- B. Thickness shall be 4" except in those areas where vehicle traffic is likely in which case the thickness shall be 6".
- C. Slope shall be 1" toward the street.
- D. Locations shall be 2' outside the lot line; however, all sidewalks must be installed in line with existing sidewalks.
- E. Elevation shall be no more than 8" above existing curb, nor more than 2" above adjacent ground level, but in all cases level with adjoining sidewalks.
- F. Where sidewalks meet driveways, curbs, or streets a 3/4" mastic expansion joint must be installed.
- G. Concrete shall be laid on subsoil firmly compacted and uniform.
- H. Concrete shall conform with Nebraska State Highway Department specification 47B air-entrained concrete.
- I. 1/2" mastic expansion joint shall be placed at intervals not greater than every 60 lineal feet of continuous sidewalk.
