computers/\$26,000 has been awarded; Mixdorf has been working on coming up with the nearly \$10,000 matching funds.

Challenged book committee volunteer: Mixdorf suggested that our "policy is only half there". If somebody challenges a book, there is no plan going forward. Mixdorf proposed developing a committee of 7 or 9 people by recruiting volunteers from various sources (Library Advisory Board, City Council/City Department Heads, and from the public) who would read the challenged book, meet for discussion, and make a decision on whether the local library would ban the book. Preston volunteered to represent the Advisory Board on this committee.

A certification training video was not presented, but Mixdorf did provide a demonstration of the library's facebook and twitter pages. It was agreed that the Board would prefer to have either an Advisory Board business meeting or a certification training video, but not both in one evening.
