Approval to apply to the Nebraska Games and Parks – Land and Water Conservation Fund for funding for two playground structures at Baumer Park for a new playground with a pour-in-place foundation and Raymond Park for a splash pad. The City of South Sioux City is requesting a Land and Water Conservation Fund grant for \$281,665 with a match share of \$281,665 for a total project cost of \$563,330.

Peters motioned, seconded by Schultz to approve and move forward to Council the request to apply to the Nebraska Games and Parks – Land and Water Conservation fund for Baumer Park and Raymond Park. Voting Aye: Schultz, Peters, Bowman and R. Bousquet. Voting No: none

Resolution to approve changes to the HOME Down Payment Assistance Program Guidelines updated.

The city receives annual allocation of HUD HOME funds as part of the Sioux City Consortium. One use of these funds include down payment assistance for low to moderate income (50-80% of AMI). Most notable changes included:

- Increased the amount (Underwriting policy) from \$10,000 to the 5-year limit of \$14,999. Guidelines on file still read \$7,000.
- Removed any home valuation cost and provided the HUD URL to the site for annual updates.
- Removed SSC title of Neighborhood Housing Coordinator (a Sioux City term) to Project Coordinator as we don't offer that program and made it more generic as several individuals can now gather the information, complete the forms and sign off on income verification information.

Schultz motioned, seconded by Peters to approve and move forward to Council the approval of changes to the HOME Down Payment Assistance Program guidelines. Voting Aye: Schultz, Peters, Bowman and R. Bousquet. Voting No: none
