Approval to authorize SIMPCO to submit an EDA grant application on behalf of the City of South Sioux City. The total project cost is \$6,230,000, with an EDA application request for construction costs only in the amount of \$5,072,430. Under a 60/40 cost share, the EDA request is \$3,043,458 and the City's match requirement is \$2,028,972. Including engineering costs of \$1,152,830, the total match commitment is \$3,181,802. The City's match will conditionally be provided by Dakota City if TIF funding is available. The project includes water and sewer extensions to support future industrial growth, specifically D Avenue Utilities, Pine Street Water Main Extension, 164th Street Sewer Extension, Dakota Avenue Water Main Replacement, and 45th Street Water Main Replacement.

Meyer motioned with recommendation to the Council authorization SIMPCO to submit an EDA grant application on behalf of the City of South Sioux City. The total project cost is \$6,230,000, with an EDA application request for construction costs only in the amount of \$5,072,430. Second by Osman. Voting Aye: Osman, Meyer, Y. Schultz and Peters. Voting No: none.
