This property is legally described as South 5' of Lot 4 and Lots 5 and 6, Block 115, Covington Addition. There was no one present requesting special services or speaking in favor of or in opposition to the conditional use permit for the construction of a 6-unit multi-family dwelling building. At 5:30 p.m., Mayor Koch declared the hearing closed.

Meyer motioned approval to apply to the FEMA SAFER (Staffing for Adequate Fire and Emergency Response) Grant to support the hiring of three new paramedic firefighters. The grant would provide 75% funding for salaries and benefits in years 1 and 2, and 35% in year 3. The estimated total cost for three hires over the three-year period is \$1,068,247.29, with the grant covering approximately \$658,752.50 and the City's cost share totaling \$409,494.79. Second by Y.
