- 1. Is this something Council wants to move forward with
- 2. If yes, are we working with a developer, if so then we need to start talking to developers to see what that might look like.
- 3. Is the city going to do it and if so are we doing it under a Planned Unit Development?
- 4. We don't have the money for budget to buy land so where does the money come from?
- 5. Do we enter into agreement with engineer in helping with plotting it.
- 6. Do we as a city purchase the land, plot and have a plan of what houses would be in that area and sell to a developer to proceed with the plan.

#### Chairman Meyer stated

- 1. Transitional get people in them then move them onto the next stage of housing
- 2. Do we have people buy them or does the city rent for an certain amount of years then move on.
- 3. Is small houses something the Council wants to consider, if so then lock land down and figure the rest out after
- 4. How much will the city control

Lori Warner from the South Sioux City Chamber stated that the Critten Center built 6 tiny homes for their 17 to 18 year olds transitioning. This helps them get on their feet. Warner stated that they have people coming into the area look at housing in the area and state the housing is to high for them to start out.
