There are 95 communities in the State of Nebraska that got that award, 69% of people in the state live in a Tree City USA community, 10,908 volunteer hours, over 17 million spent on trees and tree care, 6,811 trees were planted. Growth awards there were 32 given out in the state out of those 95 communities. South Sioux City planted 592 trees this year, \$234,145 spent on buying trees, tree management and expenses, almost \$30,000 for tree maintenance this year.
