Conditional Use permit: Billy Rogers requested to construct a new single-family home at 1017 West 3rd Street in a C3 zoning district. Municipal code requires a conditional use permit to establish residential use in a commercial zone

Rezoning request: C4 to M1 at 615 Old Highway 20 West (aka former Martins Airfield airport)
Conditional Use permit: Tire recycling in an M1 zone at 615 Old Highway 20

Conditional Use permit: residential use in a commercial zone at 219 East 12th Street (request is for garage to be converted into residential dwelling unit)
