



# SURVEY PLAT

## **SURVEYOR'S NOTES:**

- 1. THIS SURVEY WAS PERFORMED WITH THE BENEFIT OF A COMPLETE TITLE REPORT. THE REPORT WAS CREATED BY NEBRASKA TITLE COMPANY OF SOUTH SIOUX CITY AND HAS A FILE NUMBER OF 1503185 AND AN EFFECTIVE DATE OF NOVEMBER 1, 2007.
- 2. THE SURVEY PERFORMED BY WAYNE WHEELER SIGNED 04/18/01 AND RECEIVED BY THE STATE REPOSITORY ON JUNE 2, 2001, RECORDED INSTRUMENT B, SHOWS THE SOUTH PROPERTY LINE OF THE ENTIRE PARCEL RUNNING ALONG THE NORTH RIGHT-OF-WAY LINE OF OLD 164TH STREET.

FIRST, NO WHERE IN THE TITLE REPORT OR IN OUR INDIVIDUAL RESEARCH COULD WE FIND OLD 164TH STREET BEING DEDICATED TO THE PUBLIC USE. AN INTENT OF A RIGHT-OF-WAY IS OBVIOUS AND IS LONG STANDING. IT IS OUR STAND THAT IF THE RIGHT-OF-WAY IS IN EXISTENCE IT IS SIMILAR TO SECTION LINE RIGHT-OF-WAY, AND IS AN EASEMENT.

SECOND, A PORTION OF THE LONG STANDING RIGHT-OF-WAY WAS VACATED FROM THE EAST SECTION LINE TO THE EAST RIGHT-OF-WAY LINE OF THE CHICAGO NORTHWESTERN RAILROAD IN BOOK 63 PAGE 576 FILED ON SEPTEMBER 2, 1994. NO VACATION FOUND OR SUPPLIED IN REGARDS TO THIS SPECIFIC PORTION HOWEVER.

THEREFORE THE CORRECT SOUTH PROPERTY LINE IS THE SOUTH LINE OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER. THE ACRES OF RIGHT-OF-WAY ARE SHOWN PER EACH LOT.

- 3. NO DOCUMENT WAS SUPPLIED IN TITLE REPORT REGARDING THE VACATION OF ANY PORTION OF "D" AVENUE IN THE NORTHWEST QUARTER OF SECTION 4.
  THEREFORE THE 66.00 FOOT RIGHT-OF-WAY IS STILL IN EXISTENCE AND SHOWN.
- 4. THIS MONUMENT WAS FOUND BY OLSSON'S AND ASSOCIATES AND CALLED OUT AS BEING ON THE SECTION LINE AND USED FOR BPI LOT SPLIT IN THE S.E. 1/4 OF N.E. 1/4 OF SECTION 5, SURVEYED AUGUST 8, 2003, RECORDED INSTRUMENT F. THIS MONUMENT IS THE P.C. OF THE CURVE AND IS 2.16 FEET EAST OF THE SECTION LINE. A CALL WAS MADE TO TIM AITKEN, LS #458 TO CORRECT THE PLAT. HE REQUESTED WE CORRECT THE PARCEL IN OUR PLAT. MEASURED AND PLATTED DISTANCES ARE SHOWN.
- 5. LOOKING AT THE BPI LOT SPLIT, RECORDED INSTRUMENT F, ONE WOULD BELIEVE THAT THE ENTIRE PARCEL WAS OWNED BY BPI. THE SPLIT WOULD BE PLATTING 164TH ROAD WHICH INCLUDES THAT PORTION OF OLD 164TH AND "D" AVENUE. NO STATEMENT DEDICATING THIS TO THE PUBLIC IS ON THE PLAT, ALTHOUGH THE INTENT IS OBVIOUS.

I TAKE FROM THAT PLAT THAT PORTION OF OLD 164TH AND "D" AVENUE HAVE NOW BEEN DEDICATED AND IN THOSE AREAS ARE NO LONGER EASEMENT.
THEREFORE, THAT PORTION OF "D" AVENUE NORTH OF BPI'S PARCEL AND THAT PORTION OF OLD 164TH AVENUE SOUTH OF BPI'S PARCEL ARE OWNED BY THE COUNTY OR CITY, WHICHEVER HAS JURISDICTION.

IF THIS WAS NOT THE CASE, THAN THE BPI LOT SHOULD HAVE WENT WEST FROM THE EAST QUARTER CORNER A DISTANCE OF 66.86 FEET ALONG THE SOUTH LINE OF THAT PORTION OF THE SECTION, THAN NORTH TO THE NORTH RIGHT-OF-WAY LINE OF OLD 164TH ROAD. EITHER LAND IS DEDICATED AND GIVEN TO THE PUBLIC, IN WHICH CASE NO ONE PAYS TAXES ON THAT PORTION, OR THE LINE WOULD BE PLATTED TO THE SOUTH LINE AND BPI WOULD PAY TAXES ON THAT PORTION.

6. NEW 164TH STREET IS ON THE NORTH SIDE OF BPI LOT 1 AND DCS LOT 1. NO DOCUMENT WAS SUPPLIED IN TITLE REPORT IN REGARDS TO ITS DEDICATION TO THE PUBLIC. THE ASSUMPTION IS THAT A FULL 80.00 FEET OF RIGHT-OF-WAY EXISTS. IT IS LABELED AS 164TH STREET ON SURVEY PERFORMED BY MLS WE RECEIVED FROM THE CLIENT BUT NEVER FILED, IT IS LABELED AS IBP ROAD ON A SURVEY PERFORMED BY S.E.A. SIGNED APRIL 18, 2001. WE HAVE CONSIDERED IT AS A TAKE, NOT AN EASEMENT, AS NO ONE IS PAYING TAXES ON THAT PORTION.
