

Sec. 110-293. Parking on Snow Emergency Routes.

- (a) Whenever the coordinator, on the basis of falling snow, sleet or freezing rain, or on the basis of forecast by the U.S. Weather Bureau or other weather service of snow sleet or freezing rain, that weather conditions will make it necessary that motor vehicle traffic be expedited and that parking on city streets be prohibited or restricted for snow plowing and other purposes, the coordinator shall put into effect a parking prohibition on parts of or all snow emergency routes as necessary by declaring it in a manner prescribed by this division.
- (b) Notwithstanding the provisions of subsection (a) of this section, a parking prohibition shall automatically go into effect on any part of any snow emergency route on which there has been an accumulation of snow and ice of two inches or more.
- (c) Once in effect, a prohibition under this section shall remain in effect until terminated by announcement of the coordinator in accordance with this division, except that any street area which has been substantially clear of snow and ice from curb to curb for the length of the entire block shall be automatically excluded from such prohibition. While the prohibition is in effect, no person shall park or allow to remain parked any vehicle on any portion of a snow emergency route to which it applies; however, nothing in this section shall be construed to permit parking at any time or place where it is forbidden by any other provision of law.

Sec. 110-304. Snow Emergency Routes Designated.

The following streets or portions of streets within the city are designated as snow emergency routes:

- (1) Dakota Avenue From the Missouri River to the south corporate limits.
- (2) "B" Street from the Missouri River to East 34th Street
- (3) "G" Street from East Sixth to the south corporate limits.
- (4) East 39th Street from the east corporate limits to Timberline Drive.
- (5) East 29th Street-Dakota Avenue to "G" Street-West 29th Street from Dakota Avenue to the west corporate limits.
- (6) East 21st Street-Dakota Avenue to "G" Street-West 21st Street from Dakota Avenue to U.S. 77.
- (7) East 13th Street-Dakota Avenue to "G" Street
- (8) West Ninth Street-First Avenue to Ninth Avenue-East Ninth Street-Dakota Avenue to "G" Street.
- (9) East Sixth Street-Dakota Avenue to "G" Street-West Sixth Street-Dakota Avenue to Eighth Avenue.
- (10) Fifth Avenue-Missouri River to West 21st Street.
- (11) Fourth Avenue from West 21st Street to West 29th Street.
- (12) Second Avenue-West Fourth to U.S. 77.
- (13) First Avenue from West Tenth to West 17th Street.
- (14) All current and future school bus routes and Sioux City Transit routes
