YOUTH VIOLENCE PREVENTION WEEK

April 3-7, 2017

Youth Violence involves young persons who are children, youths, and young adults that are between the ages of 10 and 24. The person can be an offender, victim, or a witness to the violence. The violence is various aggressive behaviors which may include, verbal abuse, bullying, slapping, hitting, and fist-fighting. Youth violence also includes serious violent acts such as rape, robbery, assault, and homicide committed by and against youth, which may cause injury or death. Further, youths who experience violence within a dating relationship is included in this definition. Dating violence is when one person in the relationship uses power and control over their partner. Dating violence includes physical, verbal, emotional, and sexual assault.

Technology and youth are both young, fast paced, and always changing. Youths are using media technology like smart phones, I-pads, and the internet to communicate all over the world. Text messaging, chat rooms, and social networking websites i.e. Facebook, Twitter have allowed easy development of relationships with people who they may never have met in person.

There are many terms used such as cyber bullying, internet harassment, and internet bullying however electronic aggression is the term used to describe all kinds of bullying that occurs electronically. Electronic Aggression is any type of harassment or bullying which occurs through emails, chat rooms, instant messaging, websites, or text messaging. This explosion in media communication comes with possible risks. Many young people use media to embarrass, harass, or threaten their peers.

Research suggests 9% to 35% of young people report being victims of media violence. Electronic aggression is also linked to emotional distress and conduct problems at school. Further youths who have been victimized electronically are most likely to be victims off-line. This can include being sexually harassed, psychological or emotional abuse by a caregiver, witnessing an assault with a weapon, or being raped.

There are multiple types of electronic aggression. Some examples are disclosing another person's personal information to cause embarrassment, posting rumors or lies about a person, distributing or posting embarrassing pictures, or sending personal information by email. Also, assuming another person's identity electronically to post or send messages about others with the intent of causing the other person harm. The last example is sending mean embarrassing or threatening text messages, instant messages, or emails.

Tips for parents on how to keep your child safe while using electronics:

Talk to your child by asking them who they are talking to similar to how you ask who they will be with when they leave the house.

Develop rules about acceptable and safe behaviors with electronic media.

Explore the internet by visiting the sites your child visits to make sure it is safe.

Talk with other parents about how they discuss technology with their child

Connect with the school to come up with a class to educate them about policies on electronic aggression. Lastly educate yourself and stay informed about the new devices and websites your child may be using.

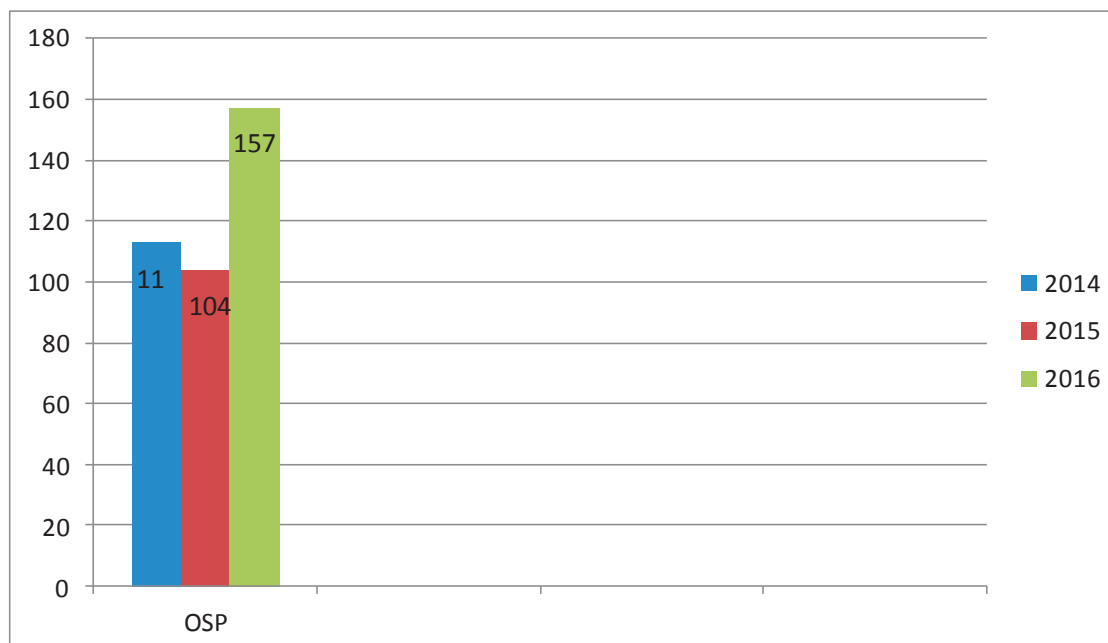

Jeff Barnes Presents "Sand Hills and Sandlots" on March 27th-

Historian, Jeff Barnes, will present "Sand Hills and Sandlots" at the South Sioux City Public Library on Monday night, March 27th at 6:30 p.m. The presentation is a part of the One Book One Siouland programming, promoting the novel *Shoeless Joe* by W.P. Kinsella.



"Sand Hills and Sandlots: is the story of the panhandle town of Rushville, which loved and played baseball like most Nebraska communities. Unlike all others, it was the recipient of a beautiful ball field from the state's biggest rancher and the host of a Major League baseball school and try-out camp, whose students included a Nebraska boy who struck out Mickey Mantle. Barnes tells the fascinating story of Rushville's 130 years with baseball and how residents past and present came together in 2014 to rebuild Nebraska's own "field of dreams."

A fifth-generation Nebraskan, Jeff Barnes is a former newspaper reporter and editor, trustee with the Nebraska State Historical Society, past chairman of the Nebraska Hall of Fame Commission, and former marketing director for the Durham Museum.

The program is sponsored by Humanities Nebraska and the Country Charmers through the HN Speakers Bureau. Speakers Bureau connects Nebraskans with over 165 authors, historians, scholars, musicians, and storytellers who give performances and speak on topics as diverse as the immigrant experience, Great Plains history, world folk music, Nebraska literature, international law, and Native American culture.

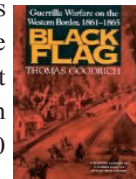

The Cookbook Book Club

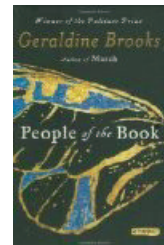

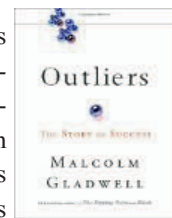
Lost in the Stacks— This month we will cover the books and movies that depict the American Civil War on Monday, March 20th at 6:30 p.m.

STANDARD RESPONSE PROTOCOL

Safety of our students and staff is one of the most important factors to a successful school district. South Sioux City Community Schools is committed to ensuring our schools are safe and our staff is prepared. To enhance this, we have decided to move to a new Standard Response Protocol (SRP) called "I Love U Guys". We feel this protocol will give us the tools to be more prepared for weather events, fires, accidents, intruders and other threats to student and staff safety.

Training has already occurred with Staff, students and first responders. Communication has been sent home to parents and the District will start with implementation in February.

SRP IS ACTION BASED

The Standard Response Protocol is based not on individual scenarios but on the response to any given scenario. SRP demands a specific vocabulary but also allows for great flexibility. The premise is simple - there are four specific actions that can be performed during an incident. When communicating these actions, the action is labeled with a "Term of Art" and is then followed by a "Directive". Execution of the action is performed

Lockout



Lockdown



Evacuate



Shelter

- **Lockout** is followed by the Directive: "Secure the Perimeter" and is the protocol used to safeguard students and staff within a building.
- **Lockdown** is followed by "Locks, Lights, Out of Sight" and is the protocol used to secure individual rooms and keep students quiet and in place.
- **Evacuate** is always followed by a location, and is used to move students and staff from one location to a different location in or out of the building.
- **Shelter** is always followed by a type and a method and is the protocol for group and self protection.

BENEFITS

The benefits of SRP become quickly apparent. By standardizing the vocabulary, all stakeholders can understand the response and status of the event. For students, this provides continuity of expectations and actions throughout their educational career. For staff, this becomes a simpler process to train and drill. For first responders, the common vocabulary and protocols establish a greater predictability that persists through the duration of an incident. Additionally, this protocol enables rapid response determination when an unforeseen
